Vision Statement

Darjeeling Ladenla Road Prerna believes in a world that sees the need to live as one family where the environment is preserved and protected, where conscious efforts are made to remove unjust structures while striving to build a just and humane society.

Mission statement

Our mission is to build sustainable human communities in the Darjeeling hills and the adjoining areas by promoting peoples participation, gender equality and living in harmony with the environment.

Goals

3. Undertake Development and Environment Education with educational institutions and community based organisations.

5. Undertake research, development and dissemination on developmental issues pertinent to the Darjeeling hills.

1. Community Development of Harsing, Dabaipani and Yangkhoo Busties

Harsing, Dabaipani and Yangkhoo Busties are part of the erstwhile Lebong and Mineral Tea Estate which closed down between 1050s and 60s. DLR Prerna's intervention started in 1996 and the community today is organized with 450 family members. The collective is registered under the West Bengal Societies Act 1961 as "Mineral Spring Sanjukta Vikash Sanstha" (MSSVS) S/1L/49564 of 2007 – 2008 dated 9th January 2008. The MSSVS was Certified Organic under international standards in 2001 and Fairtrade Labeled in 2003. It is the first Certified Organic and Fairtrade small farmers collective in the Darjeeling Hills.

The learning experience of Harsing Dabaipani and Yangkhoo is being taken to other project and partner areas.

Mineral Spring Sanjukta Vikas Sanstha activities continued in the year 2008 - 2009:

a. Small farmers organic green leaf being sold to TPI and through TPI in the International Market as well as locally in Life and Leaf as **small farmers organic fairtrade tea** under brand name "**Mineral Spring**". 48 104 kg of green leaf tea sold which made 9738 kg of made tea.

b. Fairtrade Premium received and used in a decentralized manner based on the FLO fund planning. Participatory planning processes was facilitated by trained SVS members and the development plan evolved included Fairtrade premium utilization.

c. 100% internal inspections conducted by two teams of MSSVS representatives supported by Navin Tamang and Sailesh Sharma

d. Control Union Inspection May 2008 of MSSVS with development of Approved Farmer List and Internal Control System Control Union format – **Organic Certificate Renewed**.

e. Fairtrade Audit – February 2009 of MSSVS – Producer Organisation for Tea Fairtrade labeled with corrective measures

f. Training

- Internal Control and Regulations Systems(ICS and IRS) training of trainers. The ICS and IRS training had trainees from 3 TPI small farmers collective partners(Puttong, Subarna and Teesta) besides MSSVS. The TOT was conducted in Aap Botay homestays.

h. Sanjukta Nari Sangathan(SNS), women's wing of SVC activities of micro-credit continued in the year 2008 - 2009

Time Period: 3 years

Long-term Goal Statement

Improved status of key floral and faunal species and their habitat in Singhalila National Park through conservation friendly sustainable livelihood practices.

Project Purpose/Short-term Impact

The capacity of communities in the five villages of the buffer zone of Singhalila National Park enhanced to practice sustainable livelihoods and environmentally friendly agriculture that contribute to the conservation of the national park.

Purpose Indicators

1. Change in resource use practices among at least one community group of the project site during the project period of 2 years through adoption of alternative sustainable livelihood strategies.

2. Synthetic agro-chemical use threat reduction through the adoption of sustainable natural resource management practices by 80% of the 5 communities by 3 year of the project.

Activities Undertaken

- Selection of 5 forest villages in consultation with Forest Department (Territorial) and MC member Dr. Sunita Pradhan and the community with series of meetings: (Namla, Gurdung, Daragaon, Bichgaon and Samenden)

- Selection and Training of 3 CA's for 9 days residential in the months of September 08 and February 09 along with field support each month.

- Social, resource mapping and conservation threat analysis of 5 forest village completed.

- Selection of Progressive Farmers (PF) by the community month of October 08
